WITH THE PROVINCIAL
INFORMATION
COMMISSION*

* Sindh: After 21 days, complain to the Provincial Ombudsman
Balochistan: After 30 days, complain to the Head of the Public Institution



THEN WE CAN CALL THE PUNJAB COMMISSION ON THE STATUS OF WOMEN (PCSW) HELPLINE FOR FREE LEGAL ADVICE TO TAKE YOUR CASE FORWARD*

BUT WHAT IS THE NUMBER OF THE HELPLINE AND HOW DOES IT WORK?

GREAT IDEA! THEY WILL ALSO FOLLOW UP WITH THE CONCERNED REVENUE OFFICERS OR DCO ON YOUR BEHALF BY LODGING YOUR COMPLAINT

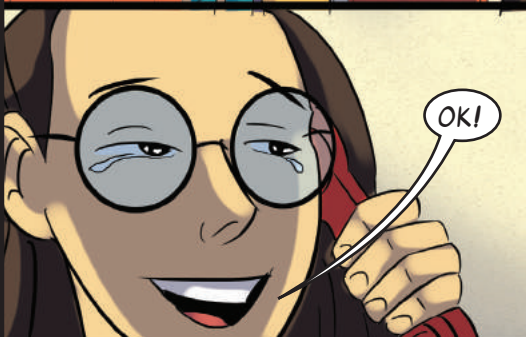

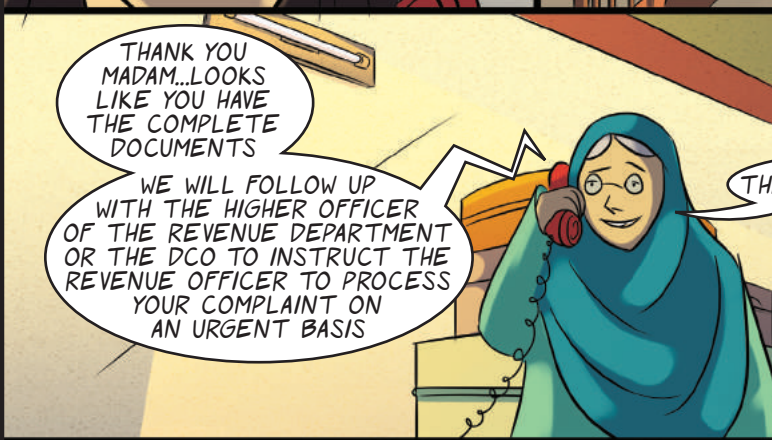

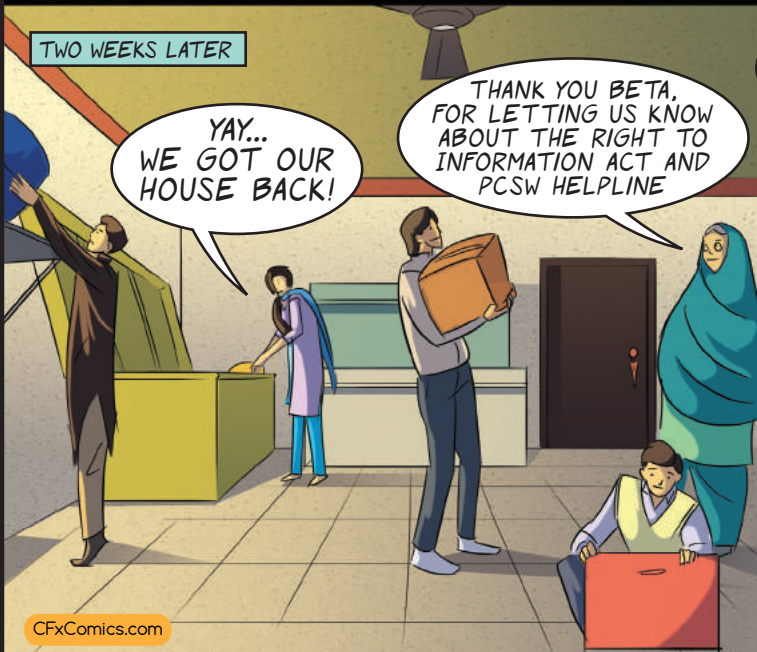
